#### **Introduction to International Relations**

#### **Global Newspaper Assignment**

Find four articles (approximately 500 words each) from national news sources (using library databases, specifically Access World News or Proquest International Newsstream) on your topic. One of your articles should be a news source, the other three must each be editorial/opinion from different countries. *Be careful that the international articles are not just reprints of articles from the United States*. You may use translated news reports from BBC Monitoring. **All articles must be from 2020 and later**.

The articles should take a position on the topic – they should not be purely descriptive; editorials are ideal. Your articles must have authors or be the product of the publication's editorial board. You should select articles that are from relevant countries and reflect a range of perspectives, not just the first articles you find. You will complete a worksheet outlining your reasoning for selecting these articles.

#### **Learning goals for this assignment:**

- 1. Become more familiar with an international topic.
- 2. Develop experience with the library databases.
- 3. Improve research skills to identify relevant non-U.S. perspectives
- 4. Practice analytical skills to become *critical consumers of political information*.
  - a. Learn to distinguish between authoritative and unreliable information sources.
  - b. Understand the importance of considering perspectives beyond U.S. media sources.
  - c. Understand when and how to cite properly.
  - d. Synthesize ideas from multiple sources.
  - e. Understand how reading multiple perspectives presents a more nuanced view of international relations.
- 5. Reflect on the value of relevant non-U.S. perspectives.

You **MUST** use the library's research databases, not Google, to find these articles. Your final report, with a cover page, page numbers, bibliography and a copy of all of the articles (not links)

will be submitted via Canvas. You can either paste your articles into a Word file or convert them to PDFs. It must be clear that you found them using library databases – articles accessed any other way do not meet the criteria of the assignment. You also need to submit your Research Worksheet.

#### SAMPLE OUTLINE:

- Introduction: Briefly describe your topic and note the importance of examining multiple perspectives on the issue your thesis should directly answer the question "Why is it important to examine this issue from multiple perspectives?"
- A brief paragraph describing the topic (draw on U.S. article)
- A summary paragraph (including specific details/quotations) for each of the three non-U.S. articles (each from a different country) and the perspectives they offer on the issue.
- A reflective concluding paragraph on how these articles helped you better understand the topic than you might have if you had relied on only the U.S. source.

Use Chicago Style (footnotes) for citation (see back of assignment for specific guidelines). There are videos on Canvas if you need help inserting footnotes in Microsoft Word or with Chicago style citation. You should also include a bibliography that includes your four articles and any sources you used to help you understand the topic. Your report should be approximately 1,000 words in length (Not including footnotes or bibliography).

## **Chicago-Style Citation Quick Guide**

The following examples illustrate citations using the notes and bibliography system. Examples of notes are followed by shortened versions of citations to the same source. You do not need to provide hyperlinks for information found in the library databases.

### Article in a newspaper or popular magazine

Who was the article written for? A local audience or global audience? How can you tell? What perspective do you think the article represents? Why?
